Code Chapters 215, 217, 219, 220, 224 - 226, 230 and 232, enclosed in your April 19, 2002 letter and which was received by this office on May 2, 2002. These regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Parts 19, 20, 30, 31, 32, 33, 34, 35, 36, 39, 40, 61, 70, 71, 150 and the requirements of the 35 amendments identified in the enclosed State Regulation Status (SRS) Data Sheet. In addition, we reviewed our January 5, 2001, letter to you that addressed the proposed regulations and your response to our comments. We discussed our review of the regulations with you on May 5, 2003.

As a result of our review, we have identified 11 comments, as enclosed. We did not review your incorporation of 10 CFR 35 because your incorporation references, documented in 25 PA. Code Chapter 215, were for the old Part 35 medical rules. If the State would like to incorporate this section by reference, it is requested that you change your incorporation references and submit this section again. Please note, that we have limited our review to regulations required for compatibility and/or health and safety.

Please provide an amended final version of your rules showing the location of any changes made by the State in response to our comments. If there are any comments which the State believes are in error, the State should identify the section of their regulations that meet the designated compatibility category and submit these sections to the NRC for review.

The SRS Data Sheet summarizes our knowledge of the Pennsylvania regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the SRS Data Sheet.
