Davis-Besse Nuclear Power Station - Inspection Exits and Restart Meeting

On February 12, 2004, the NRC's Restart Readiness Assessment Team and the Management and Human Performance Team presented the results of their recent inspections at a public exit meeting near the site. Later in the day, the 0350 Oversight Panel conducted a public restart meeting with the licensee at the same location. The Region III Administrator, Director of the Office of the Nuclear Reactor Regulation, and Deputy Executive Director for Reactor Programs attended these meetings. The restart meeting was also attended by State and local elected officials, licensee employees, public citizens, and media representatives. Additionally, a telephone bridge line was established to enable participation in lieu of travel.

Tennessee Valley Authority (TVA) Chief Nuclear Officer to Retire

On February 13, 2004, TVA Chief Nuclear Officer, Mr. John Scalice, who has led TVA's nuclear program for 14 years, announced his plans to retire, effective June 1, 2004. Mr. Karl Singer, senior vice president of nuclear operations, is expected to assume the position of Chief Nuclear Officer on June 1, 2004. Mr. Singer has approximately 20 years of nuclear reactor experience. He served in the U.S. Navy from 1984 to 1993, then joined TVA at the Browns Ferry Nuclear Plant in Alabama.

Vermont Yankee Extended Power Uprate Acceptance Review

On February 18, 2004, the NRC staff verbally informed Entergy that the staff has completed its acceptance review of the Vermont Yankee Extended Power Uprate license amendment application dated September 10, 2003, as supplemented on October 1 and October 28, 2003, and January 31, 2004. The staff has determined that the licensee has provided the necessary information such that the detailed review can be completed within a 12-month review schedule. The expected completion date for NRC review is January 31, 2005.

Industry Corrective Action Program Owners Group (CAPOG) Meeting

On February 18, 2004, Division of Inspection Program Management (DIPM) staff participated in a meeting of the CAPOG in Las Vegas, NV. During this meeting, the staff made a presentation on its analysis of recent corrective action program inspection findings and provided an overview of recent changes to the inspection program related to trending. Attendees included representatives from industry, Nuclear Energy Institute (NEI), and other corrective action program stakeholders.

Reactor Oversight Process (ROP) Meeting

On February 19, 2004, DIPM staff hosted the monthly ROP Working Group meeting to discuss general mitigating systems performance index (MSPI) related topics, industry's responses to the staff's draft maintenance rule significance determination process (SDP), and ways to

improve the barrier integrity performance indicators (PIs). Discussions also included ways of creating a top ten ROP issues list and frequently asked questions (FAQs) on ROP PIs.

#### Public Information Session on License Renewal Review Process

On February 27, 2004, the staff conducted a public information session in Waterford, Connecticut, to discuss the NRC process for considering license renewal applications. The session was conducted following the receipt of the license renewal application for the Millstone Power Station, Units 2 and 3. The staff placed advertisements in local newspapers and on local public access radio stations, distributed flyers to local community organizations, and issued a press release announcing the information session. Approximately 35 people attended the session. The public questions related mostly to the role of the Advisory Committee on Reactor Safeguards (ACRS) and on the recently revised 10 CFR Part 2 requirements related to public hearings. The meeting was well attended by local and state government officials including a State Representative from the 38<sup>th</sup> District.

#### Petition to Intervene in System Energy Resources, Inc. Early Site Permit Proceeding for Grand Gulf

The NRC received a petition dated February 12, 2004, from four organizations to intervene in the System Energy Resources, Inc. (SERI) early site permit (ESP) application proceeding for Grand Gulf. In accordance with 10 CFR Part 52, a hearing is mandatory for an ESP, and a petition to intervene is the first step in admitting parties as litigants in that hearing. The organizations cited in the petition, that represent 14 individuals who live within 50 miles of the proposed Grand Gulf ESP site, are the National Association for the Advancement of Colored People, Claiborne County, Mississippi Branch; Nuclear Information and Resource Service; Public Citizen; and Mississippi Chapter of the Sierra Club. The petition asserts nine aspects the petitioners believe are within the scope of the proceeding for which they request to intervene.

#### Meeting of Electric Power Research Institute (EPRI) Plant Support Engineering Cable Users Group

On February 9-13, 2004, the Division of Engineering staff participated in the subject meeting. Discussions included the staff's February 5, 2004, letter to NEI, regarding the potential common mode failure of medium voltage underground cables due to wetting. The letter encouraged the industry to develop proposals that would address cable issues by April 30, 2004. Industry participants objected to the use of the term "common mode" stating that only random failures due to "water treeing" are possible. Industry participants also objected to the April 30, 2004, response date, as being unrealistic because of the potential complexity of this issue.

Meeting with Russian Federation Gosatomnadzor

On February 10-12, 2004, Office of Nuclear Material Safety and Safeguards staff participated in a meeting in Moscow, Russia, to discuss comment resolutions on first drafts of selected Federal-level regulations and safety guides developed by the Russian Federation Gosatomnadzor (GAN). Comments on the regulations and safety guides were previously provided to GAN by NRC, the European Commission, and the Department of Energy (DOE) and its contractors. The regulations and safety guides are related to the Russian mixed-oxide (MOX) fuel project and are part of the Russian infrastructure support project funded by DOE. DOE requested NRC's participation at this meeting and funded it through a reimbursable agreement. This activity is part of NRC continuing support to DOE and GAN, related to the Russian MOX program.

Third Phenomena Identification and Ranking Table (PIRT) meeting for the ACR-700 Design

On February 18-20, 2004, the subject meeting was held at NRC Headquarters. Subpanels on thermal-hydraulics and severe accidents met in parallel sessions over the three days of this meeting. An independent panel of thermal-hydraulics experts met to develop a PIRT for a critical break loss-of-coolant accident (LOCA) in the ACR-700, a design basis event. The PIRT will be used to guide code development and determine the need for new experiments. The findings will be used by the panel to formulate recommendations for modification of NRC's severe accident analysis tools.

Meeting with the Representatives of the Department of Energy

On February 19, 2004, RES and NRR staff met with representatives of the Department of Energy (DOE) to discuss implementation of a Congressional mandate for DOE to transfer mechanical stress improvement process (MSIP) technology to Lithuania. MSIP is used to remediate residual stresses in stainless steel piping thereby reducing the likelihood of intergranular stress corrosion cracking at pipe welds.

Indian Point Exercise Coordination

On February 18-19, 2004, staff from NRC Region I and the NRC Offices of Nuclear Reactor Regulation, Nuclear Security and Incident Response, Public Affairs, and Nuclear Regulatory Research participated in several on-site activities associated with development and coordination of the June 8, 2004 Indian Point emergency preparedness exercise. The NRC staff participated in a tabletop exercise involving representatives from the Indian Point site, State of New York, and four counties in the Indian Point emergency planning zone (EPZ). In addition, the NRC staff reviewed the current exercise plan with representatives from the Federal Emergency Management Agency Region II office. These meetings were held to ensure adequate participation by evaluated responders and to discuss planned outreach activities in support of the exercise.

Oyster Creek

On February 19, 2004, AmerGen Energy Company announced plans to seek extension of Oyster Creek Generating Station operating license by 20 years. The current license expires April 9, 2009. AmerGen plans to submit a license renewal application to the NRC in mid-2005.
