Information Notice (IN) 2005-15: Three-Unit Trip and Loss of Offsite Power at Palo Verde Nuclear Generating Station

On June 1, 2005, NRC issued the subject IN to alert addressees to electrical equipment failures and design deficiencies identified following the loss-of-offsite power event that had occurred in June 2004 at Palo Verde Nuclear Generating Station. The IN requires no specific action nor written response; however, licensees are expected to review the information for applicability to their facilities and consider taking actions, as appropriate.

Regulatory Issue Summary (RIS) 2005-08: Endorsement of Nuclear Energy Institute (NEI) Guidance "Range of Protective Actions for Nuclear Power Plant Incidents"

On June 6, 2005, NRC issued the subject RIS to inform addressees of NRC's endorsement of the NEI guidance as an acceptable range of early-phase protective actions that licensees may use in the event of a nuclear power plant incident. The RIS requires no specific action nor written response; however, licensees are expected to review the information for applicability to their facilities and consider taking actions, as appropriate.

Staff Visit to German Nuclear Institutes to Discusses the Anticipated Behavior and Condition of Spent Fuel

On May 30, 2005, Division of High-Level Waste Repository Safety staff visited two nuclear institutes in Karlsruhe, Germany; (1) the Institute für Nukleare Entsorgung, a German laboratory; and (2) the Institute for Transuranic Elements, a European Union laboratory. The two institutes are active in research on the behavior of radionuclides under Germany's anticipated high-level waste repository conditions. The staff exchanged views with the institutes' staff on the anticipated behavior of actinides and the anticipated condition of spent nuclear fuel that would be received at a repository.

One-month Extension of the May 30, 2003, Confirmatory Order Issued to J. L. Shepherd & Associates

On June 1, 2005, the Office of Enforcement issued an Order to J. L. Shepherd & Associates (JLS&A), a manufacturer of nuclear irradiators and commercial research calibration equipment based in San Fernando, CA, extending the expiration date of the May 30, 2003, Confirmatory Order, from June 1, 2005, to July 1, 2005. The May 30, 2003, Confirmatory Order allowed relaxation of certain provisions of the Order dated July 3, 2001 (i.e., allowed JLS&A to make shipments through June 1, 2005), as authorized by a conditional approval of its QA Program. The NRC extended the expiration date of the May 30, 2003, Confirmatory Order by one month to accommodate the staff's review of JLS&A's April 7, 2005, request, to rescind the Order of July 3, 2001.

DOE's Hanford Facility

On June 1, 2005, staff and management from the Division of Waste Management and Environmental Protection met with representatives of the Department of Energy (DOE) to discuss: (1) a review of the DOE Hanford Office of River Protection responses to NRC's Requests for Additional Information regarding the basis for exception to the Hanford Federal Facility Agreement and Consent Order, specifically dealing with waste retrieval criteria for Single-Shell Tank 241-C-106; and (2) the methodology for the Hanford Single-Shell Tank System Performance Assessment.

Quarterly DOE/NRC Meeting on Proposed High-Level Waste Repository

On June 6, 2005, NRC staff and the Department of Energy (DOE) representatives held a public management meeting in Pahrump, Nevada, to discuss the progress of the proposed geologic repository at Yucca Mountain, Nevada. After the meeting, NRC management and staff met informally with members of the public to discuss matters of interest related to the Yucca Mountain Project and NRC's role in licensing a geologic repository.

Federal Interagency Public Workshop on Concrete Materials Performance for Nuclear Facilities

On June 2, 2005, RES organized and hosted the subject workshop. The objectives of the workshop were to facilitate communication among Federal agencies and interested stakeholders on research studies and their findings on concrete materials performance for nuclear reactor structures, and waste disposal facilities that may employ concrete-based engineered barriers for waste isolation. The participants at the Workshop included cognizant NRC staff from the Offices of Nuclear Reactor Regulation, Nuclear Material Safety and Safeguards, Advisory Committee on Nuclear Waste, and concrete materials performance researchers from the National Institute of Standards and Technology, the U.S. Army Corps of Engineers, and Oak Ridge National Laboratory. Technical presentations at the Workshop provided NRC staff with current research information on degradation mechanisms in concrete and methodologies that can be used to monitor concrete structure performance.

List of Approved Spent Fuel Storage Casks: HI-STORM 100, Amendment 2, Revision (AH64 - Part 72)

On June 7, 2005, NRC published a final rule in the Federal Register (70 FR 32977) that revises 10 CFR 72.214, "List of Approved spent Fuel Storage Casks," to incorporate Amendment No. 2 to Certificate No. 1014 for the Holtec International's Storage and Transfer Operation Reinforced Module System (HI-STORM 100). This action modifies the cask design to include changes to construction materials, types of fuel that can be loaded, shielding and confinement methodologies, and various temperature limits. The final rule became effective June 7, 2005.

Annual Assessment Meeting for Salem and Hope Creek

On June 8, 2005, Region I held its Annual Assessment Meeting with Public Service Enterprise Group (PSEG) to discuss performance at the Salem and Hope Creek stations. The evening public meeting also included discussions of PSEG's progress in addressing equipment reliability and safety conscious work environment issues at the site as well as a recent manual reactor shutdown at Hope Creek. The reactor shutdown was in response to the increasing rate of reactor coolant system leakage inside the containment. There were approximately 75 people in attendance.

Public Meeting with Pacific Gas and Electric Company (PG&E)

On June 7, 2005, Region IV held a public meeting in San Luis Obispo, California, with PG&E representatives to present the NRC's annual assessment of Diablo Canyon Power Plant safety performance. In addition to describing the Reactor Oversight Process and the assessment results, other topics of discussion included plant security, the National Academy of Science's recent report on spent nuclear fuel storage, PG&E's planned independent spent fuel storage installation, and emergency sirens. Approximately 60 people, including members of the public, public interest groups, and a local official attended the meeting. The meeting was video taped and will be shown on the local government channel.

Public Meeting with Wolf Creek Nuclear Operating Corporation

On June 9, 2005, Region IV held a public meeting with Wolf Creek Nuclear Operating Corporation to present the NRC's annual assessment of Wolf Creek Generating Station safety performance. The meeting was held at the Coffey County Library, in Burlington, Kansas. The purpose of the meeting was to describe the Reactor Oversight Process, discuss licensee performance at Wolf Creek for the Calendar Year 2004, and discuss topics of potential interest to the public. Three local officials and one member of the public attended the meeting. There was no media coverage.
