The well logging industry operates at temporary jobsites throughout the nation under reciprocity in both NRC and Agreement State jurisdiction. Agreement States need to adopt regulations for well logging (Part 39) to maintain a compatible program. Due to the potential for temporary jobsites under reciprocity well logging (Part 39 requirements), Nevada needs to revise 459.7721 to meet the Compatibility Category C designation assigned to Section 10 CFR 39.65.
