Issues/Actions requested:

That the NRC issue an emergency order for a temporary closure or de-rating of the Vermont Yankee Nuclear Power Station (VY) as a result of flood damage to the city of Keene, town of Hinsdale in New Hampshire, and other portions of New Hampshire that are part of existing evacuation routes for VY and are within the effluent pathway in an emergency event.

Background:

During a telephone conversation with the petition manager on October 18, 2005, the petitioner informed the staff that he had received information from FEMA regarding the State of New Hampshire's awareness of evacuation issues at the time of the flooding and that alternate routes had been evaluated. Therefore the staff determined that the emergency request for temporary plant closure or de-rating was not necessary and was subsequently denied by the NRC's Petition Review Board (PRB). The petitioner further emphasized his broader concern regarding demonstration that FEMA and the State of New Hampshire actually have plans for an evacuation if an event occurred at VY simultaneously with a natural disaster such as the recent flooding. During the call, the petition manager informed the petitioner that his request met the criteria for review under 10 CFR 2.206. The petitioner was offered an invitation to address the PRB with additional information to support the petition but declined.

A combined acknowledgement letter and proposed Director's Decision was issued on December 7, 2005. The letter requested comments within 30 days. In its proposed Decision, the staff denied the Petitioner's request to shut down or de-rate the station because it concluded that there was no threat to the public health and safety. During the recent flooding, the State had established and coordinated potential alternate evacuation routes in the event of an accident at Vermont Yankee, and safe operation of the station was not threatened by the flooding.

Current Status:

No comments were received on the proposed Director's Decision. The staff issued the final Decision on March 4, 2006.

Issues/Actions requested:

The petitioner is requesting that the NRC issue a Demand for Information requiring licensees to submit information related to monitoring of radioactively contaminated water and leakage detection systems.

Background:

The petitioner provided several examples of the release from various nuclear facilities of water containing radioactive materials. The petitioners contend that the multiple examples raise the possibility of similar unmonitored releases at other nuclear facilities.

Current Status:

The staff has determined that the petition meets the criteria for review under 10 CFR 2.206. By letter dated February 2, 2006, the petitioner supplemented his petition to add three new petitioners. By letter dated June 29, 2006, the staff informed the petitioner that the petition had been accepted for review under 10 CFR 2.206.

The staff has offered the petitioner an opportunity to address the PRB. The petitioner has accepted and a meeting will be scheduled at a mutually agreeable date and time.

Issues/Actions requested:

The petitioner is requesting that the NRC issue a Demand for Information to Exelon Generation Company, requiring them to demonstrate that emergency preparedness planning for day care and nursery school populations within each facilities' Emergency Planning Zone is adequate or that adequate interim compensatory actions have been taken. The petitioner also requests that the indirect license transfers associated with the PSEG-Exelon merger be held in abeyance until the licensees can demonstrate compliance with the licenses with regards to emergency planning.

Current Status:

The petitioner addressed the PRB during a teleconference on December 21, 2005. Based on the information provided in the petition and the teleconference, and in consultation with FEMA, the staff determined that the petition does not meet the criteria for review under 10 CFR 2.206. The NRC based its decision on the adequacy of emergency preparedness for commercial nuclear power plants on a review of the FEMA findings and determinations regarding the State and local emergency plans and on the NRC assessment of the licensee's onsite emergency plans. Demanding information from the licensee would not facilitate our assessments since we are already engaged in discussions with the Department of Homeland Security (DHS) and offsite response organizations regarding this matter. The questions about the evacuation of childcare facilities are currently being considered by the NRC, DHS, and the appropriate offsite response organizations as a result of mr. Epstein's inquiries, other activities within Pennsylvania (e.g., legislation related to licensing childcare facilities), the Commission's directions to the NRC staff associated with the denial of the petition for rulemaking, and the DPO filed by a member of the NRC staff.
