Memorandum and Order in License Renewal Application for Palisades Nuclear Plant

On March 7, 2006, the Atomic Safety and Licensing Board (ASLB) issued a Memorandum and Order ruling on standing, contentions and other pending matters related to the subject license renewal application. The ASLB ruled that the Petitioners established standing but did not submit any admissible contentions under applicable NRC regulation and precedent. Therefore, the adjudicatory proceeding was terminated.

Pilgrim Public Information Session on License Renewal Review Process

On March 8, 2006, the staff conducted the subject public information session in Plymouth, Massachusetts. The session was conducted following the receipt of the license renewal application for the Pilgrim Nuclear Power Station to provide information on the license renewal process and opportunities for public involvement. Representatives from Region I, Office of Public Affairs, Office of the General Counsel, Office of Congressional Affairs, and the Office of Nuclear Security and Incident Response (NSIR) supported this public information session.

Economic Simplified Boiling Water Reactor (ESBWR) Fuel meeting

On March 1, NRR and Office of Nuclear Regulatory Research (RES) staff participated in a meeting with General Electric (GE) and Global Nuclear Fuels (GNF) at the GE/GNF offices in Wilmington, NC, regarding the ESBWR fuel design and critical heat flux (CHF) correlation. GE has submitted several topical reports providing detailed fuel design information and one additional submittal regarding the CHF correlation is expected this week. Meeting discussion topics included the need for additional justification for classification of the control rod drop accident as beyond design basis for ESBWR, the acceptability of the proposed acceptance criteria for the control rod withdrawal error event, additional fuel design details needed to support NRC confirmatory calculations, and justification of the applicability of the GE critical quality-boiling length CHF correlation to the ESBWR.

Public Meeting on Security Design Expectations for New Reactors

On March 6, NRR and NSIR staff hosted a public meeting with Nuclear Energy Institute (NEI) on the proposed rulemaking for security design expectations for new reactors. During the meeting, staff discussed the purpose and schedule for the rulemaking, listened to comments from industry representatives, and answered questions on the rulemaking process. Industry representatives indicated their intentions to develop several documents that may help with the development of staff's guidance documents in support of the rule. Staff and industry agreed to continue to interact throughout the rulemaking process.

ESBWR Severe Accidents and Probabilistic Risk Assessment (PRA) meeting

On March 8, 2006, NRR and RES staff met with GE to discuss the ESBWR severe accident (SA) analysis and the treatment of thermal-hydraulic (T/H) uncertainty in the PRA. During the

SA portion of the meeting, the NRC's contractor, Energy Resources Incorporated, presented preliminary results of confirmatory SA analyses performing using the MELCOR code and comparisons with GE's MAAP results. The preliminary results showed good agreement between the two codes. Additional ESBWR design details were requested by ERI to further refine the MELCOR input deck.

During the T/H uncertainty portion of the meeting, GE presented its proposed approach for addressing an NRC's request for additional information on this topic. The NRC staff agreed in principle to the approach proposed by GE to benchmark the MAAP code with the NRC approved TRACG code, and to perform additional TRACG comparisons for events where MAAP calculated minimal core uncover or low margin to core uncover. The staff indicated that additional details, when submitted, would have to be reviewed before the staff could agree that the PRA success criteria established with MAAP/TRACG were appropriate.

NRC Audits Watts Bar's New Emergency Core Cooling System (ECCS) Sump Strainer Design

On March 6, the staff met with the Tennessee Valley Authority to begin the second phase of its audit of Watts Bar's new ECCS sump strainer design. This audit is one of the ten that the staff plans to conduct in support of Generic Safety Issue 191, "Assessment of Debris Accumulation on PWR Sump Performance," closure over the next two years. Initial discussions with the licensee covered various technical subjects, including Loss of Coolant Accident/net positive suction head analysis, break selection, sump structure analysis, debris generation and transport, head loss testing, chemical effects, and downstream effects.

Withdrawal of Proposed Rule on Post-Fire Operator Manual Actions (AH54- Part 50)

On March 7, 2006, the NRC published a document in the Federal Register (70 FR 10901) that withdraws a proposed rule that would have amended its fire protection regulations for nuclear power facilities. The proposed amendment would have allowed nuclear plant licensees to use manual actions by plant operators as an alternative method to achieve hot shutdown conditions in the event of fires in certain plant areas. The proposed rule is withdrawn because, after evaluating stakeholder comments, the Commission believes that the proposed rule would not have achieved its stated objectives of effectiveness and efficiency.
