Regional Utility Group Meeting

On November 30, 2006, the staff from the Office of Nuclear Reactor Regulation (NRR) and from Regions I and III participated the Region III Utility Group safety culture workshop in Chicago, IL. The full-day workshop covered the recent Reactor Oversight Process safety culture related changes and how the licensees will be affected by those changes.

NRC/Technical Specifications Task Force Public Meeting Regarding Administrative Processing of Generic Changes to the Standard Technical Specifications

On November 30, 2006, the Technical Specification Task Force (TSTF) and the staff conducted a public meeting regarding generic changes to the Standard Technical Specifications (i.e., Travelers). The staff and the TSTF discussed the NRC administrative processes associated with TSTF Travelers, and reviewed the status of Travelers formally proposed by industry. The TSTF also presented and solicited the NRC feedback on Travelers under consideration for submission to the NRC.

Public Meeting on the Proposed Revision to NUREGs-1122 and 1123

On November 29, 2006, the staff held a public meeting with members of the Pressurized Water Reactor Owners Group and Boiling Water Reactor Owners Group to discuss their proposed revision to the "Generic Section" of the pressurized water reactor and boiling water reactor "Knowledge and Abilities Catalogs," NUREGs-1122 and -1123, respectively, that the NRC uses to develop operator licensing examinations. The owners groups will submit their proposed revisions the week of December 4. The staff expects to complete its review of the industry proposed revisions and publish the draft revisions to the NUREGs for public comment during early part of 2007.

European Commission Workshop on Design and Assessment of Packages for Radioactive Waste

On November 21-22, 2006, NRC staff participated in the subject workshop in Bergen, the Netherlands. The Workshop focused on information relevant to evaluating the performance of spent nuclear fuel and waste packages in a high-level waste repository, and on identifying and planning future international collaborative work. Participants discussed future collaborative tests and the development of international guidance on waste packages. Staff presented a paper on container, cladding, and waste forms in high-level waste, and exchanged information with participants from European Union countries, Japan, and Korea.

Issuance of S300 Certificate of Compliance

On November 28, 2006, the staff issued Certificate of Compliance No. 9329 to the U.S. Department of Energy (DOE) for its Model No. S300 Fissile Material Transport Package (Model No. S300). The Model No. S300 packaging is designed to transport a single plutonium-beryllium special form capsule. DOE intends to use the Model No S300 for recovery and disposal of these capsules.

November 2006 Publication of Brookhaven National Laboratory Report, "Recommendations for Revision of Seismic Damping Values in Regulatory Guide 1.61," NUREG/CR-6919

RES published the subject report which provides recommendations for the selection of damping values used in the seismic analysis and design of nuclear power plants. The recommendations in this report considered recently published guidance included in the American Society of Chemical Engineers Standard 43-05, "Seismic Design Criteria For Structures, Systems, and Components in Nuclear Facilities," and in the American Society of Mechanical Engineers Boiler and Pressure Vessel Code, Section III, Division 1, Non-Mandatory Appendix N, "Dynamic Analysis Methods", 2004 Edition.

Public Meeting to Discuss Plans to Develop Guidance for Implementing 10 CFR 20.1406, "Minimization of Contamination"

On November 21, 2006, RES staff conducted the subject meeting to exchange information on activities underway by industry and the NRC concerning the provisions of 10 CFR 20.1406. The Nuclear Energy Institute (NEI) noted its members' voluntary activities, including waste minimization, contamination reduction, and ground-water protection. Westinghouse is developing Technical Reports for the Advanced Passive Reactor (AP1000) to address effluent releases and radiation protection. The NRC's activities include revising the Standard Review Plan for new reactor licenses, developing a regulatory guide, revising 10 CFR 20.1406 to broaden its applicability based on cost/benefit analyses, and preparing a report on implementation of environmental monitoring requirements. The next public meeting is being planned for early January 2007 for focused discussions on these activities.

Probabilistic Risk Assessment (PRA) Scope and Quality Workshop

On November 6-7, 2006, RES staff participated in the subject Electric Power Research Institute (EPRI) sponsored Workshop. Topics included the Treatment of Uncertainty, Support System Initiating Events, and Treatment of Loss of Offsite Power in PRAs. RES staff discussed a proposal to identify, prioritize and resolve model "technical adequacy" issues through an NRC-industry cooperative effort.
