 - NRC program issues/gaps



All goals were met in FY 2006


Abnormal Occurrences

Licensee Performance Issues/ NRC Program Gaps

- One nuclear materials licensee met the significant performance issues criteria
- No significant trending issues identified
- No NRC program gaps or failures identified


Trending Review of Event Data

- Reviewed 4 years (10/01/02 to 9/30/06), 1,972 events during this period.
- No significant performance trends identified.
- No significant change from previous 4 year period that had 2,038 events.

Agreement State and NRC Event Comparison

- 452 reportable events for FY 2006
 - 335 Agreement State Events (74%)
 - 117 NRC Events (26%)
- Consistent with number of licensees (80% Agreement State and 20% NRC)

Unrecovered Lost and Stolen Sources FY 2006, by Source Category



• "Other" category represents sources that are not listed in Appendix P of 10 CFR 110 or IAEA Code of Conduct and are sources that are not of significant concern.
