Public Meeting in Erwin, TN, Regarding National Nuclear Security Administration Report

On April 2, 2008, Office of Nuclear Material Safety and Safeguards (NMSS) staff participated in a public town hall meeting in Erwin, TN. The NMSS and Region II staff addressed public concerns regarding a U.S. Department of Energy (DOE) report. DOE's National Nuclear Security Administration (NNSA) issued its 2007 supplement to the environmental impact statement (EIS) for the NNSA program to dispose of highly enriched uranium. NNSA determined that a new EIS was not required but included a footnote in the report characterizing the risk of cancer. The public was concerned about the information in the footnote. At the public meeting, NNSA staff provided background information on its program and the role played by Nuclear Fuel Services. The public asked questions concerning the data used by NNSA and the results presented in the report. The NRC staff addressed questions concerning the environmental monitoring program. Members of the public encouraged the NRC and NNSA to make more information available to the public and to hold more public meetings. There was coverage by the local media. Representatives from Senators Alexander's and Corker's offices attended the meeting.

National Source Tracking System Expansion Proposed Rule

On April 11, 2008, a proposed rule to expand the number and types of sources to be tracked in the National Source Tracking System (NSTS) was published in the *Federal Register*. In November, 2006, the U. S. Nuclear Regulatory Commission issued a final rule to establish a NSTS requiring licensees who possess International Atomic Energy Agency (IAEA) Category 1 and 2 sources to report to the NSTS. The proposed rule would amend 10 CFR Parts 20 and 32 to expand the NSTS to include sources greater than or equal to one-tenth of the IAEA Category 3 threshold. The public comment period is for 75 days.
