IP 84850 (Radioactive Waste Management - Inspection of Waste Generator Requirements of 10 CFR Part 20 and 10 CFR Part 61) has been revised to change document ownership to the Office of Federal and State Materials and Environmental Management Programs (FSME), add a new management control, include minor modifications to allow flexibility in meeting disposal site requirements, and add a reference to 10 CFR Part 20 Appendix G.

IP 84900 (Low-Level Radioactive Waste Storage) has been revised to add references related to Orders for increased control, fingerprinting and criminal history. This revision also adds qualifications of waste storage personnel, several factors related to adequacy of storage area, storage infrastructure, and storage environs, and package handling considerations and deletes discussion related to resources.

The following Inspection Manual Chapters (IMCs) & Inspection Procedures (IPs) have been deleted based on their current applicability, time since last revision, and the number of hours charged to the procedure within the past 15 years. The majority of these documents have been superseded by the Reactor Oversight Process (ROP).
