PURPOSE: The purpose of this meeting is to solicit external stakeholder input on interim enhanced Allegation program guidance recently developed for use by the Nuclear Regulatory Commission (NRC) staff. These enhancements were developed in response to lessons learned regarding the agency's handling of allegations in March 2007 and September 2007 of inattentive security officers. Specifically, the NRC seeks input on the following four specific aspects of guidance outlined in Allegation Guidance Memorandum (AGM) 2008-001, "Interim Guidance in Response to Lessons Learned from the Allegation Assessment of Inattentive Security Officers at Peach Bottom Atomic Power Station:"

- Contacting Allegers
- Allegation Request for Information (RFI) Worksheet
- Allegation RFI Letters to the Licensee
- Checklist for NRC Assessment of Licensee Response to RFIs

The AGM, dated December 29, 2008, is publicly available in the NRC's Agencywide Documents Access and Management (ADAMS) system <http://www.nrc.gov/reading-rm/adams/web-based.html> (Accession No. ML083640272).

In addition, the NRC seeks external stakeholder input on the viability of sharing allegation evaluation outcomes with persons other than the allegor who may have similar concerns, without jeopardizing the allegor's identity. This action was directed by an NRC Senior Executive Review Panel (SERP). The SERP Report, dated March 4, 2008, is also publically available in ADAMS (Accession No. ML080570429).
