Pre-licensing Meeting with Pacific Gas and Electric Company (PG&E)

On March 3, 2010, representatives of PG&E met with the staff to discuss the proposed digital instrumentation and control upgrade of the Eagle 21 system. The Eagle 21 system provides trip status and parameter input signals to the Solid State Protection System (SSPS), which provides the reactor trip and engineered safety component actuation functions. The licensee expects to submit a license amendment for the proposed modification in May 2011, which is about 20 months later than originally projected. The current analog SSPS will continue in service pending NRC approval of the proposed amendment.

Acceptance of Surry and LaSalle Measurement Uncertainty Recapture Power Upgrades

By separate applications, both dated January 27, 2010, the licensees for Surry Units 1 and 2 and LaSalle Units 1 and 2 requested 1.6% measurement uncertainty recapture (MUR) power upgrades using the Cameron CheckPlus™ Leading Edge Flow Meter system. By letter dated March 4, 2010, (for Surry), and e-mail dated March 5, 2010, (for LaSalle), NRC informed these licensees that their applications provide technical information in sufficient detail to enable the staff to proceed with its detailed technical reviews. The applications request NRC approval by August 31, 2010, (for Surry) and November 29, 2010, (for LaSalle). NRC's standard review time for a MUR power upgrade is 6 months after acceptance of the application.

Public Telephone Conference with Waterford Licensee

On March 8, 2010, the staff held a public telephone conference meeting with the licensee for Waterford to discuss the licensee's planned responses to a staff request for additional information regarding Generic Letter 2004-02, "Pressurized Water Reactor Sump Performance."

Second European MELCOR User Group (EMUG) 2010 Annual Technical Meeting

On March 1-2, 2010, RES staff and Sandia National Laboratory attended the subject EMUG international meeting and made presentations on the status of MELCOR development and code applications (ML100540003). The meeting was organized and sponsored by Nuclear Research Institute and Czech Republic State Office for Nuclear Safety in collaboration with NRC and Paul Sherrer Institute in Switzerland. The purpose of the meeting was to exchange technical information on MELCOR code applications and user experience. A total of 42 participants from various organizations in 12 countries attended the meeting and made 22 presentations.

Publication of Draft Regulatory Guide 1242 (DG-1242) "Service Level I, II, and III Protective Coatings Applied to Nuclear Power Plants"

On March 9, 2010, RES staff issued DG-1242 to provide an opportunity for public comments. The draft guide is proposed Revision 2 to Regulatory Guide 1.54 that describes acceptable methods to monitor the effectiveness of maintenance for Category I, II, and III protective coatings in nuclear power plants. Alternate Fracture Toughness Requirements for Protection against Pressurized Thermal Shock Events: Final Rule; Correcting Amendment, 10 CFR Part 50 (RIN 3150-AI01, NRC-2007-0008)

On February 8, 2010, the NRC published a final rule (75 FR 10410) in the *Federal Register* revising its regulations to add a table that was inadvertently omitted in a correction document (75 FR 5495) published on February 3, 2010. The February 3, 2010, document corrected a final rule (75 FR 13) published on January 4, 2010, that amends the NRC's regulations to provide alternate fracture toughness requirements for protection against pressurized thermal shock events for pressurized water reactor pressure vessels. The correction is effective March 8, 2010, and is applicable to February 3, 2010, the date the original rule became effective.

Nuclear Energy Institute, Denial of Petition for Rulemaking; 10 CFR Part 73 (PRM-73-14, NRC-2009-0493)

On March 8, 2010, the NRC published a notice (75 FR 10444) in the *Federal Register* denying a petition for rulemaking submitted by the Nuclear Energy Institute. The petitioner requested that the NRC amend the compliance date for specific requirements in the NRC's physical protection regulations for nuclear power plants. The NRC denied the petition because there is not sufficient time before the compliance date of March 31, 2010, to allow the NRC to collect and analyze the data necessary to complete an adequate notice and comment rulemaking.

Technical Assistance for Quality Assurance Review Support of License Renewal Applications

On March 9, 2010, as a result of a noncompetitive acquisition, a cost plus fixed-fee type contract (NRC-03-10-070) was awarded to Southwest Research Institute, Inc. in San Antonio, Texas to provide technical assistance to the Office of Nuclear Reactor Regulation in the area of quality assurance for the review and evaluation of License Review Applications. The period of performance is from March 9, 2010, through September 28, 2012, with one 1-year option period. The total value is \$873,502.00, which is inclusive of all options.
