Issuance of the Safety Evaluation Report (SER) Related to the License Renewal of Cooper Nuclear Station

By letter dated September 1, 2010, the staff issued the SER related to the license renewal of Cooper Nuclear Station. The SER addressed the license renewal application submitted by Nebraska Public Power District by letter dated September 24, 2008. The staff performed its review in accordance with Title 10, Part 54, of the *Code of Federal Regulations*, "Requirements for Renewal of Operating Licenses for Nuclear Power Plants." The current license expires at midnight on January 18, 2014. The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards in a public meeting to be held in October 2010 to discuss the SER.

Public Teleconference on the Draft Aging Management Program for Buried and Underground Piping and Tanks

On September 1, 2010, the staff conducted a public teleconference meeting to discuss revisions made to the draft Generic Aging Lessons-Learned Report aging management program (AMP) XI.M41, "Buried and Underground Piping and Tanks." During the teleconference, industry stakeholders and members of the public discussed with the NRC staff their written comments on the draft AMP. The NRC staff held this teleconference to allow for continued discussion of stakeholder comments following a teleconference on August 24, 2010.

Issuance of the Safety Evaluation Report Related to the License Renewal of Duane Arnold Energy Center

By letter dated September 3, 2010, the staff issued the SER related to the license renewal of Duane Arnold Energy Center. The SER addressed the license renewal application submitted by Florida Power and Light Energy Duane Arnold, LLC., by letter dated September 30, 2008. The staff performed its review in accordance with Title 10, Part 54, of the *Code of Federal Regulations*, "Requirements for Renewal of Operating Licenses for Nuclear Power Plants." The current license expires at midnight on February 21, 2014. The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards in a public meeting to be held in October 2010 to discuss the SER.

Source Term License Amendments for LaSalle County Station

On September 7, 2010, the staff issued a full-scope alternate source term amendment to the licenses for LaSalle County Station, Units 1 and 2. The amendments revise the Technical Specifications to support the application of alternative source term methodology with respect to the loss-of-coolant accident and the fuel handling accident at each unit.

Acquisition Support for the Office of Administration

On September 2, 2010, as a result of an 8(a) non-competitive solicitation, a firm fixed price contract (NRC-10-10-425) was awarded to Suntiva, LLC in Falls Church, Virginia for acquisition support services for the Office of Administration. The period of performance is September 2, 2010, through March 1, 2011, with two 6-month option periods. The total estimated ceiling cost is \$982,451.00, inclusive of all options.

Office of Small Business and Civil Rights (SBCR) Renovation Project

On September 2, 2010, as a result of an 8(a) noncompetitive acquisition, a firm fixed price contract (NRC-10-10-419) was awarded to Kaleo Construction, Inc. in Sterling, Virginia. This contract will provide all necessary construction services required to complete the refurbishment of the SBCR office. All work shall be completed no later than 90 days after the NRC provides the contractor with a notice to proceed for construction, with no option periods. The total cost is \$280,059.53.

Revised Replacement Energy Costs for Nuclear Power Plants

On September 3, 2010, as a result of a competitive negotiated acquisition, a firm fixed-price type delivery order (NRC-DR-03-10-074) was awarded to IHS Global Insight, Inc. in Lexington, Massachusetts for a report titled "Revised Replacement Energy Costs for Nuclear Power Plants." The period of performance is September 2, 2010, through August 31, 2011, with no option periods. The total value of the delivery order is \$134,148.00.
