Issuance of Renewed Operating License for Vermont Yankee Nuclear Power Station

On March 21, 2011, the operating license for Vermont Yankee Nuclear Power Station was renewed, authorizing operation for an additional 20 years beyond the original license expiration date. The new expiration date is March 21, 2032. The staff completed its review, as documented in the Safety Evaluation Report (SER), NUREG-1907 published in May 2008 and in two SER supplements published in September 2009 and March 2011. The Supplemental Environmental Impact Statement, NUREG-1437 Supplement 30, was published in August 2007. The issuance of the Vermont Yankee Nuclear Power Station renewed license brings the total number of renewals to 63 reactor units.

Public Meeting on Turkey Point, St Lucie, and Point Beach Transition to National Fire Protection Association (NFPA) 805

On March 22, 2011, the staff held a Category 1 public meeting with Florida Power and Light Company representatives to discuss the transition to 10 CFR 50.48(c), NFPA 805, for Turkey Point, Units 3 and 4, St. Lucie, Units 1 and 2, and Point Beach, Units 1 and 2.

Public Meeting on Catawba and McGuire transition to NFPA 805

On March 23, 2011, the staff held a Category 1 public meeting with Duke Energy representatives to discuss the transition to 10 CFR 50.48(c), NFPA 805, for Catawba, Units 1 and 2, and McGuire, Units 1 and 2.

NMSS System Training Course

On March 22, 2011, staff from NMSS provided opening remarks and greetings to the industry representatives who attended the training class for reporting site information to the Nuclear Materials Management and Safeguards System (NMMSS) database. This hour training course was presented by the operator of the NMMSS database and designed to explain the process and procedures for reporting receipts, shipments, and inventory of source and special nuclear materials to the database. The training course was held at the Department of Energy's (DOE) Germantown, Maryland site. This training course is offered approximately twice a year. NMSS implements an Interagency Agreement with DOE that allows the NRC to utilize the NMMSS database. All NRC and the Agreement State licensees who possess a gram or more of special nuclear material are required to report their receipt, shipment, and inventory of special nuclear material to the NMMSS database.

License Tracking System (LTS) Upgraded

On March 14, 2011, FSME has launched version 2.2 of the LTS. LTS 2.2 replaced and enhanced all features previously available in the legacy LTS. The Web-Based Licensing (WBL) system will be built on the LTS platform and many of the requirements for WBL are being addressed in new LTS releases. Additionally, the NRC is developing a distributed version of LTS to provide to the Agreement States for use. The LTS Distributed Version is based on version 2.2.

Economic Simplified Boiling-Water Reactor (ESBWR) Design Certification; Proposed Rule
(RIN 3150-AI85, NRC-2010-0135)

On March 24, 2011, the NRC published a proposed rule (76 FR 16549) in the *Federal Register* proposing to amend its regulations to certify the ESBWR standard plant design. This action is necessary so that applicants or licensees intending to construct and operate an ESBWR design may do so by referencing this design certification rule (DCR). The applicant for certification of the ESBWR design is General Electric-Hitachi Nuclear Energy. The public is invited to submit comments on this proposed DCR, the generic design control document (DCD) that would be incorporated by reference into the DCR, and the environmental assessment (EA) for the ESBWR design. Comments on the DCR, DCD, and/or EA are due by June 7, 2011. Comments specific to the information collections aspects of this proposed rule are due by April 25, 2011.

Since the Japan disaster on March 11, 2011, the NRC has responded to approximately 550 inquiries from the public and 500 inquiries from the media.

OPA did a recorded interview with talk radio station WVOP-AM in Vidalia, Georgia, on the NRC's inspection program at Edwin Hatch nuclear power plant (Georgia).

OPA helped coordinate the Commission briefing on the situation in Japan, at which Chairman Jaczko gave remarks.

OPA supported public meetings at Braidwood and Robinson nuclear power plants.

OPA developed a website off its main page with information on the NRC's activities with regard to the Japan nuclear event.
