General Site Suitability Criteria for Nuclear Power Stations; Draft Regulatory Guide; Request for Comment; 10 CFR Parts 50, 51, and 52 (NRC-2011-0297)

On December 30, 2011, the NRC published in the *Federal Register* (76 FR 82201) Draft Regulatory Guide DG-4021, "General Site Suitability Criteria for Nuclear Power Stations," for public comment. This guide describes a method that the NRC staff considers acceptable to implement the site suitability requirements for nuclear power stations. Comments are requested by February 25, 2012.

Measurement and Control of Combustible Gas Generation and Dispersal; Petition for Rulemaking (PRM); Notice of Receipt; 10 CFR Parts 50, 52, and 100 (PRM-50-103; NRC-2011-0189)

On January 5, 2012, the NRC published in the *Federal Register* (77 FR 441) a notice of receipt of a petition for PRM, dated October 14, 2011, from the Natural Resources Defense Council, Inc. The petitioner requested that the NRC amend its regulations regarding the measurement and control of combustible gas generation and dispersal within a power reactor system. The NRC is not instituting a public comment period for this PRM at this time.

Receipt and Availability of License Renewal Application for Callaway Plant Unit 1

On December 19, 2011, the staff received an application from Union Electric Company requesting the renewal of the operating license for Callaway Plant, Unit 1 (Callaway), for an additional 20 years beyond the current 40-year term. The current operating license expires at midnight on October 18, 2024. The application is available at the Web site <http://www.nrc.gov/reactors/operating/licensing/renewal/applications/callaway.html> and in ADAMS under Accession No. ML113530374. The staff tentatively plans to hold a public information session near the plant in early 2012 to provide an overview of the license renewal process and to solicit public comments on the scope of the staff's environmental review.

Management Directive (MD) 6.5 “NRC Participation in the Development and Use of Consensus Standards Issued”

The Regulatory Guide Development Branch revised and issued MD 6.5, “NRC Participation in the Development and Use of Consensus Standards,” on December 20, 2011. MD 6.5 provides direction for implementing the National Technology Transfer and Advancement Act of 1995 (Public Law 104-113) and the Office of Management and Budget Circular No. A-119, “Federal Participation in the Development and Use of Voluntary Consensus Standards and in Conformity Assessment Activities.” MD 6.5 provides organizational responsibilities and guidance for staff participation in the development of consensus standards, including identifying and prioritizing needed new and revised technical standards, selecting, and nominating staff as authorized agency representatives on standards developing organization (SDO) committees, and coordinating standards activities with SDOs and other stakeholders. The MD also provides guidance for use of consensus standards in the NRC regulatory framework.
