Grant Award to the National Academy of Sciences

As a result of language in the Conference Report, H. Rep. 112-331, accompanying the Consolidated Appropriations Act of 2012, Pub. L. 112-74, a non-competitive grant was awarded to the National Academy of Sciences of Washington, DC. The purpose of the grant is to assess the lessons learned from the Fukushima nuclear accident for improving safety and security at U.S. nuclear plants. The period of performance is from February 2, 2012, to April 30, 2014. The value of the grant award is \$2,000,000.

NRC Staff Meeting with Japanese Counterparts

On January 30, 2012, staff from NMSS met with staff from the Japan Nuclear Energy Safety Organization, the Central Research Institute of Electric Power Industry, and the Ministry of Economy, Trade, and Industry to discuss topics related to dry storage of spent nuclear fuel. The discussions covered details of the U.S. regulatory framework and technical areas for current and potential extended dry storage.

NRC Staff Meetings for Waste Confidence and Extended Storage

On January 31, 2012, staff from NMSS held a public webinar to discuss its draft report, "Background and Preliminary Assumptions for an Environmental Impact Statement—Long-Term Waste Confidence Update," which was issued for public comment in late December 2011. The webinar was co-hosted by the Council of State Governments, Midwest Division, and had over 140 participants. Staff also presented similar material on the draft report at the 27th Annual Spent Fuel Forum of the Institute of Nuclear Materials Management, in Arlington, VA, on February 1, 2012.

National Fire Protection Association 805 Site Audit at the Callaway Plant

On January 27, 2012, staff concluded a week-long National Fire Protection Association 805 site audit at the Callaway plant in Fulton, MO. The audit team received presentations, conducted interviews, held breakout sessions, reviewed site- specific documentation, and toured the licensee's facility. The staff plans to issue an audit summary report in the coming weeks.

Audit of Florida Power & Light Co.'s Extended Power Uprate (EPU)

On January 30 and 31, 2012, the staff visited the office of AREVA, in Lynchburg, VA, to conduct an audit related to Florida Power & Light's EPU application for their St. Lucie Unit 1 plant. The principal areas of concern were loss-of-coolant accident (LOCA) and non-LOCA analyses, and thermal conductivity degradation issues. AREVA provided revised analyses for several non-LOCA events, and additional information related to the realistic LOCA analyses, all of which were in response to prior requests for additional information that were issued by the staff. All of the staff's concerns were adequately addressed in the audit.

Staff Holds Public Meetings Related to the License Renewal Process for Grand Gulf Nuclear Station

On January 31, 2012, staff conducted two identical public meetings in Port Gibson, MS, to discuss the license renewal review process and to solicit public comments concerning the scope of the environmental review for the Grand Gulf Nuclear Station, Unit 1, license renewal application. Approximately 30 people attended the meetings, including the applicant, local residents, government officials, citizen organizations, and news media. Public comments included concerns regarding emergency preparedness and aging management. Public scoping comments are due by February 27, 2012.
