Information Technology (IT) Research and Advisory Subscription Services

On June 27, 2012, as a result of a competitive General Services Administration Schedule solicitation, a fixed price delivery order (GS35F5014H /NRC-HQ-12-F-33-0001) was awarded to Gartner, Inc. of Stamford, CT. The contractor will provide IT research and advisory subscription services. The period of performance is from July 1, 2012, to June 30, 2013, with a 1-year option period. The total value of the delivery order is \$644,680, inclusive of all options.

Human Resources Training and Development Training Support Services – Courseware Design

On July 3, 2012, as a result of a non-competitive, 8(a) solicitation, a Fixed Price Labor Hour, IDIQ contract (NRC-HQ-12-C-38-0079) was awarded to Battle Resource Management, Inc. of Clarksville, MD. The contractor will provide the agency with Training Support Services, specifically in assessing training needs and courseware design/development. The period of performance is from July 3, 2012, to September 30, 2012, with four 1-year option periods and a fifth option period for 9 months. The total estimated value of the contract is \$950,000, inclusive of all options.

Receipts-Based, Small Business Size Standard; Direct Final Rule; 10 CFR Parts 2 and 171 (RIN 3150-AJ14; NRC-2012-0062)

On July 3, 2012, the NRC published a direct final rule in the *Federal Register* (77 FR 39385) to amend the size standard that it uses to qualify an NRC licensee as a “small entity” under the Regulatory Flexibility Act of 1980, as amended. The NRC is proposing to increase its receipts-based, small business size standard from \$6.5 million to \$7 million to conform to the most commonly used size standard set by the Small Business Administration (SBA). The SBA adjusted this standard on July 18, 2008 (73 FR 41237), to account for inflation. The direct final rule is effective August 22, 2012, unless significant adverse comments are received by August 2, 2012. A companion proposed rule was published in the *Federal Register* on July 3, 2012 (77 FR 39442). Comments on the proposed rule are due by August 2, 2012.
