Dear Mr. Snee:

We have reviewed the proposed and final revisions to the Ohio regulations in the Ohio Administrative Code Chapters 3701:1-38, 3701:1-40, 3701:1-44, 3701:1-46, 3701:1-49 and 3701:1-52, received by our office on December 19, 2012. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Parts 30, 31, 32, 36, 39, 40, 70, 150 and the requirements of the three amendments identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Mark Light on February 1, 2013.

As a result of our review of the proposed revisions, we have two comments that have been identified in the enclosure. Please note that we have limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that the Ohio regulations meet the compatibility and health and safety categories of the equivalent NRC regulation may only be made based on a review of the final Ohio regulations. However, we have determined that if your proposed regulations were adopted, incorporating our comments and without other significant change, they would meet the compatibility and health and safety categories established in the Office of Federal and State Materials and Environmental Management Programs (FSME) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in FSME Procedure SA-201, "Review of State Regulatory Requirements," please highlight the final changes, and provide a copy to Division of Materials Safety and State Agreements, FSME.

As a result of our review of the final revisions, we have no comments. We have determined that the final regulations, as adopted, meet the compatibility and health and safety categories established in the FSME Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

The SRS Data Sheet summarizes our knowledge of the status of other Ohio regulations and legally binding requirements, as indicated. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet.
