Physical Protection of Byproduct Material: Final Rule and Guidance; 10 CFR Parts 20, 30, 32, 33, 34, 35, 36, 37, 39, 51, 71, and 73 (RIN 3150-A112; NRC-2008-0120 (Rule) and NRC-2010-0194 (Guidance))

On March 19, 2013, the NRC published a final rule in the *Federal Register* ([78 FR 16922](#)), effective May 20, 2013, amending its regulations to establish security requirements for the use and transport of category 1 and category 2 quantities of radioactive material. Category 1 and category 2 thresholds are based on the quantities established by the International Atomic Energy Agency in its Code of Conduct on the Safety and Security of Radioactive Sources, which the NRC endorses. The objective of this final rule is to provide reasonable assurance of preventing the theft or diversion of category 1 and category 2 quantities of radioactive material. The rule also considers a petition for rulemaking (PRM-71-13) submitted by the State of Washington that requested that the NRC adopt the use of global positioning satellite tracking as a national requirement for vehicles transporting highly radioactive mobile or portable radioactive devices. The NRC also issued an implementation guidance document associated with this final rule in this document.

List of Approved Spent Fuel Storage Casks: MAGNASTOR[®] System; 10 CFR Part 72 (RIN 3150-AJ22; NRC-2012-0308)

On March 18, 2013, the NRC published a direct final rule in the *Federal Register* ([78 FR 16601](#)), effective June 3, 2013, amending its spent fuel storage cask regulations by revising the NAC International, Inc. MAGNASTOR[®] System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 3 to Certificate of Compliance No. 1031. The companion proposed rule was also published on March 18, 2013 ([78 FR 16619](#)). The confirmation of effective date for this direct final rule will be published in the *Federal Register* at a later date.

Publication of Final Rule: Part 37 “Physical Protection of Byproduct Material

On March 19, 2013, the final rule on the “Physical Protection of Byproduct Material,” commonly referred to as the Part 37 rule, was published in the *Federal Register*. The rule will be effective on May 20, 2013, and the compliance date will be March 19, 2014, which means that licensees will not implement the final rule until March 19, 2014. The rule codifies the security requirements for category 1 and category 2 quantities of radioactive material. Agreement States will have until March 19, 2016, to establish compatible requirements.

Controlled Unclassified Information (CUI)

On March 21, 2013, staff from the Office of Information Services attended a working group meeting at the Controlled Unclassified Information Office (CUIO), National Archives and Records Administration. The purpose of the meeting was to continue discussions on the proposed policy for safeguarding, dissemination, and decontrol of controlled unclassified information (CUI). The CUI Executive Agent (EA) has asked each agency to designate a Senior Agency Official and Program Manager for their CUI Program by April 30, 2013. The draft policy will be circulated once more for comments before finalization and submission to Office of Management and Budget for publication in the Federal Register. The CUIO estimates dispatching the final draft to agencies in late May/early June, with comments due in July 2013. The EA estimates publication of the final policy in the *Code of Federal Registry* in February/March 2014. This is a change from the earlier estimated date of November 2013. A CUI Implementation Management Council is being established to develop the implementation planning framework for the new CUI policy, and the EA is encouraging agencies to begin discussions on their individual implementation plans.

Public Meeting on Neutron Absorbing Materials

On March 14, 2013 the staff held a public meeting on neutron absorbing materials in spent fuel pools. The purpose of the meeting was for staff to dialogue with the nuclear industry vendors on relevant information pertaining to neutron absorbing materials. Neutron absorbers are important because many licensees credit them for maintaining sub-criticality in their spent fuel pools. At the meeting, the vendors gave presentations on more recently developed neutron absorbing materials for spent fuel pool applications. In particular, the vendors presented information on various topics such as: manufacturing processes, quality controls, testing, and material properties.
