SUBJECT:	SUMMARY OF THE JUNE 19, 2013, PUBLIC MEETING CONDUCTED BY THE U.S. NUCLEAR REGULATORY COMMISSION TO SOLICIT INPUT ON THE FOREIGN OWNERSHIP, CONTROL, OR DOMINATION REQUIREMENTS OF COMMERCIAL NUCLEAR POWER PLANTS

On June 19, 2013, the U.S. Nuclear Regulatory Commission (NRC) conducted a Category 3 Public Meeting at NRC Headquarters, One White Flint North, 11555 Rockville Pike, Rockville, MD, 20852 to solicit input from industry and other interested groups on the foreign ownership, control, or domination (FOCD) requirements in Title 10 *Code of Federal Regulations* (10 CFR) 50.38, 10 CFR 52.75(a), and 10 CFR 54.17(b). The public meeting was held as part of the NRC staff's effort related to the March 11, 2013, Commission issued Staff Requirements Memorandum (SRM)-12-0168, directing the staff to provide a fresh assessment on FOCD and provide its conclusions in a policy paper due to the Commission on December 31, 2013 (Enclosure 1 - Agencywide Documents Access and Management System (ADAMS) No. ML10370A150). A list of attendees is provided as an attachment to this Public Meeting Summary. Also, the public meeting was transcribed, and the transcript can be found at ML13184A091 (Enclosure 2)

The NRC opened the meeting with an overview of the SRM and the current regulatory framework in Sections 103d. and 104d. of the Atomic Energy Act of 1954, as amended and the current NRC regulations, the Standard Review Plan on "Foreign Ownership, Control, or Domination of Applicants for Reactor Licenses" dated June 1999 (64 FR 52,355) (Enclosure 3 - ML003752184) and the path forward (Enclosure 4 - ML13171A337).

In addition staff noted that, on June 3, 2013, the NRC issued a *Federal Register Notice* for a 60day comment period on the issues presented in SRM-12-1068. The intent of the public outreach and publishing an FRN was to explore and receive written input on the FOCD issues identified in the SRM.

Paul Murphy (Milbank, Tweed, Hadley & McCloy LLP) presented on the considerations from a financing perspective (Enclosure 5 - ML13169A118).

Michael Mariotte (Nuclear Information and Resource Service), the third presented, discussed FOCD of U.S. nuclear reactors (Enclosure 7 - ML13169A180).

Ellen Ginsberg (NEI), the forth presenter, provided industry's perspectives on FOCD issues and the global nuclear market (Enclosure 8 - ML13170A231).

The fifth and final presentation was by John Matthews (Morgan Lewis), who discussed focusing the FOCD restrictions on national security (Enclosure 9 – ML13169A096).

There were a variety of comments from licensees, applicants and members of the public on their perspectives on FOCD. Industry stated their view that foreign financing does not equal control over the facilities and that there should be changes to the FOCD SRP. Members of the public, both in the audience and on the telephone bridgeline stated that any proposed changes, such as implementing potentially new programs to monitor mitigation measures would be time consuming and a waste of resources. In addition, members of the public also stated that the NRC should not be considering allowing additional foreign ownership so that new reactors can be built.

Comments provided during the meeting, and as part of the public comment period, will be evaluated and considered in developing the Commission policy paper on FOCD. The NRC staff reminded meeting attendees that that the public comment period for providing written comment on the FOCD issues identified in the FRN ends on August 3, 2013.
