ADAMS P8-Related Applications - Operations and Maintenance Support

On August 13, 2013, as a result of a competed task order under a multiple award indefinite delivery/indefinite quantity (IDIQ) contract, a labor hour task order (NRC-HQ-11-C-33-0059/NRC-HQ-13-T-33-0027) was awarded to CGI Federal, Inc., of Fairfax, VA. This contract will provide operations and maintenance support for ADAMS P8-related applications. The period of performance is from August 13, 2013, to September 25, 2014, with three 1-year option periods. The total value of the contract is \$5,712,903, inclusive of all options.

ADAMS P8 Core Systems - Operations and Maintenance Support

On August 13, 2013, as a result of a competed task order under a multiple award IDIQ contract, a labor hour task order (NRC-HQ-11-C-33-0059/NRC-HQ-13-T-33-0028) was awarded to CGI Federal, Inc., of Fairfax, VA. Nuclear Medical Resource Professionals Users Group and Medical Review Officer/Physicians Focus Meetings

On August 6-8, 2013, the staff attended the annual Nuclear Medical Resource Professionals Users Group and Medical Review Officer/Physicians Focus Meetings in Clearwater Beach, FL. Regulatory requirements related to the medical fitness of licensed nuclear power plant operators were discussed, including certification of medical examinations and reporting of medical conditions using NRC Form 396 and fitness for duty issues affecting licensed operators. In addition, the recently published 2013 revision of ANSI/ANS-3.4, "Medical Certification and Monitoring of Personnel Requiring Operator Licenses for Nuclear Power Plants" was discussed. It is anticipated that the industry would voluntarily adopt this standard governing medical examinations for licensed operators pending its endorsement by the NRC via a revision to Regulatory Guide 1.134.

Reactor Oversight Process (ROP) Working Group Public Meeting

On August 7, 2013, the staff conducted an ROP Working Group public meeting. Meeting participants included NRC staff and industry representatives. Discussions included updates on probabilistic risk assessment operational support, assessment topics, possible changes to the performance indicator guidance, and frequently asked questions. The next ROP Working Group public meeting will be held on September 11, 2013.

IAEA Operational Safety Review Team Mission

By letter dated August 16, 2013, the United States Mission to International Organizations in Vienna informed the International Atomic Energy Agency that the Clinton Power Station will host an Operational Safety Review Team (OSART) mission in 2014. This will be the eighth OSART mission in the United States.
