Dear Mr. Snee:

We have reviewed the proposed changes to the Ohio regulations 3701:1-50-1 and 3701:1-50-23, received by our office on September 13, 2013. These regulations were reviewed by comparison to the equivalent U.S. Nuclear Regulatory Commission (NRC) rules in 10 CFR Part 71 and the requirements of the one amendment identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with Mark Light on October 23, 2013.

As a result of our review, we have no comments. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that the regulations, as proposed, meet the compatibility and health and safety categories established in the Office of Federal and State Materials and Environmental Management Programs (FSME) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements." We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in FSME Procedure SA-201, "Review of State Regulatory Requirements," please highlight any final changes and provide a copy to Division of Materials Safety and State Agreements, FSME.

The SRS Data Sheet summarizes our knowledge of the status of other Ohio regulations, as indicated. Please note as discussed with Mark Light of your staff on September 24, 2013, the correction has been made to one of the SRS Data Sheet entries transmitted with our September 18, 2013, letter. Please let us know if you note any inaccuracies, or have any comments on the information contained in the SRS Data Sheet.
