SUBJECT: SUMMARY OF NOVEMBER 14 PUBLIC MEETING IN ROCKVILLE,
MARYLAND, TO RECEIVE COMMENTS ON THE WASTE
CONFIDENCE DRAFT GENERIC ENVIRONMENTAL IMPACT
STATEMENT AND PROPOSED RULE

On Tuesday, November 14, 2013, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public meeting at NRC headquarters in Rockville, Maryland. The purpose of the meeting was to provide an overview of the Waste Confidence draft generic environmental impact statement (DGEIS) and proposed rule, and to accept public comments on the documents. Participants also had an opportunity to ask questions about the NRC's environmental review and rulemaking process. The meeting was viewable online via live webcast, and a moderated teleconference line was available for remote participants to ask questions and present comments.

The NRC conducted an open house beginning at 1:00 p.m. EST where members of the public met informally with NRC staff and asked questions related to the DGEIS and proposed rule. The public meeting began at 2:00 p.m. EST and concluded at 4:43 p.m. EST. The meeting began with an introduction of NRC staff and a review of meeting ground rules, followed by a short presentation on the Waste Confidence DGEIS and proposed rule. The majority of the meeting was dedicated to receiving comments from members of the public.
