**Low-Level Radioactive Waste Disposal Rulemaking and Strategic Assessment of Low-Level Radioactive Waste Regulatory Program: Public Workshop; 10 CFR Part 61 (RIN 3150-AI92; NRC-2011-0012)**

On January 24, 2014, the NRC published a document in the *Federal Register* ([79 FR 4102](#)) regarding its plans to conduct a public workshop on March 7, 2014, in Phoenix, Arizona. The purpose of the public workshop is to discuss proposed revisions to the NRC's Low-Level Radioactive Waste (LLRW) disposal regulations and gather information on an update to the NRC's 2007 Strategic Assessment of the LLRW regulatory program from stakeholders and other interested members of the public.

On January 30, 2014, the NRC published a document in the *Federal Register* ([79 FR 4825](#)) regarding its plans to hold a public meeting on February 5, 2014, in Rockville, Maryland. The purpose of the public meeting is to discuss the NRC's proposed rule to amend its regulations for material control and accounting of special nuclear material and the associated proposed guidance documents.

**Public Meetings on Draft Supplemental Environmental Impact Statement (SEIS) for Grand Gulf Nuclear Station**

On January 29, 2014, the staff held two identical public meetings in Port Gibson, Mississippi, to discuss the preliminary findings of, and receive public comments on, the draft supplemental environmental impact statement (SEIS) on the proposed renewal of the operating license for Grand Gulf Nuclear Station, Unit 1. The preliminary finding of this report is that the adverse environmental impacts of license renewal for Grand Gulf are not great enough to deny the option of license renewal for energy-planning decision-makers. Approximately five people attended each meeting. The public comment period will close on February 11, 2014. The staff plans to issue the final SEIS by September 2014.
