<u>Definition of a Utilization Facility: Direct Final and Proposed Rule; Correction; 10 Code of Federal Regulations Part 50 (Regulation Identifier Number (RIN) 3150-AJ48; NRC-2014-0238)</u>

On November 5, 2014, the NRC published corrections to direct final (79 FR 65541) and companion proposed rules (79 FR 65603) to correct the docket identification number and RIN for rules previously published in the *Federal Register* on October 17, 2014. The direct final rule (79 FR 62329) would amend the NRC's regulations to add SHINE Medical Technologies, Inc.'s accelerator-driven subcritical operating assemblies, as described in the application assigned docket number 50-608, to the definition of utilization facility. The final rule will be effective December 31, 2014, unless significant adverse comments are received on the companion proposed rule (79 FR 62360) by November 17, 2014. The corrections were effective November 5, 2014.

<u>Issuance of Byron Station. Units 1 and 2. and Braidwood Station. Units 1 and 2. Safety</u> Evaluation Report with Open Items

On October 30, 2014, the staff issued the Safety Evaluation Report (SER) with Open Items related to the Byron Station, Units 1 and 2, and the Braidwood Station, Units 1 and 2, (BBS) license renewal application. The staff identified two open items and is scheduled to meet with the Advisory Committee on Reactor Safeguards Subcommittee on December 3, 2014, to discuss the BBS SER with Open Items and inspection activities.

Final Rule for American Society of Mechanical Engineers Code (ASME) Cases

On November 5, 2014, the staff published the final rule to amend Title 10 of the *Code of Federal Regulations*, Sections 50.54, 50.55, and 50.55a, to incorporate by reference the latest revisions of the following three previously incorporated regulatory guides (RG) that approve code cases published by the ASME: RG 1.84, "Design, Fabrication, and Materials Code Case Acceptability, ASME Section III," Revision 36; RG 1.147, "Inservice Inspection Code Case Acceptability, ASME Section XI, Division 1," Revision 17; and RG 1.192, "Operation and Maintenance Code Case Acceptability, ASME OM [Operation and Maintenance Code]," Revision 1. This rulemaking also allows requests that alternatives to NRC-approved ASME Boiler and Pressure Vessel and OM Code Cases be approved by the NRC. This change resolves a petition for rulemaking, PRM 50-89, submitted by Mr. Raymond West. Finally, this rulemaking will re-sequence the order of requirements in Section 50.55a in order to align with the Office of the Federal Register's requirements for incorporation by reference.
