SUBJECT: SUMMARY OF FEBRUARY 28 PUBLIC MEETING/WEBINAR TO  
DISCUSS CATEGORY 3 SOURCE SECURITY AND  
ACCOUNTABILITY

On February 28, 2017, two public meetings/webinars were held at the Houston Marriott at the Texas Medical Center in Houston, Texas. The purpose of the public meetings/webinars was to solicit comments on questions published in a *Federal Register* Notice (FRN) (82 FR 2399), with subsequent correction (83 FR 4938), related to whether it is necessary to revise the U.S. Nuclear Regulatory Commission (NRC) regulations or processes governing source protection and accountability for Category 3 sources. The questions were used to facilitate discussion during the public meetings/webinars. The feedback received during the public meetings/webinars will be used to inform NRC's evaluation and recommendations, the results which will be documented in a notation vote paper that will be submitted to the Commission in August 2017.

The NRC staff began the public meetings/webinars with information regarding how to submit comments in response to the questions in the FRN, which was published on January 9, 2017. Then, NRC staff provided some background on the activities that led to the evaluation of whether it is necessary to revise NRC regulations or processes governing Category 3 source protection and accountability, the formation of the NRC/Agreement State Category 3 Source Security and Accountability Working Group, and the activities to be completed by that group. The charter for the working group is available in the NRC's Agencywide Documents Access and Management System (ADAMS) under Accession No. ML17010A017. The NRC staff also discussed the security and accountability enhancements under consideration and provided a

brief explanation of the information technology systems involved in supporting source tracking and license verification functions (National Source Tracking System [NSTS], Web-Based Licensing System [WBL], and License Verification System [LVS]). The NRC staff then moved to the comment portion of the meeting and solicited feedback on each of the 22 questions listed in the FRN. Participants asked clarifying questions on potential reporting requirements if NSTS and LVS were expanded to include Category 3 sources. Comments provided during the meeting included the approximate number of Category 3 Sources regulated by NRC or the Agreement States, comments on LVS and NSTS, the functions of LVS and whether LVS could have prevented the U.S. Government Accountability Office sting, the usefulness of NSTS information and the security of the NSTS system.

There were 45 participants in the public meeting and webinar. Participants represented members of the public, NRC and Agreement State licensees, Agreement States, industry organizations, and the NRC. A list of meeting attendees and the meeting agenda are attached.

Staff closed out the meeting by reminding participants that the comment period for the FRN closes on March 10, 2017, and that a final public webinar would be held during the comment period to facilitate feedback.
