Dear Mr. Chairman:

On behalf of the U.S. Nuclear Regulatory Commission (NRC), as required by the Small Business Regulatory Enforcement Fairness Act of 1996, I am reporting on the status of the agency provision of "Compliance Guides" to small entities for rules that affect them.

The agency directs much of its regulatory activity to NRC licensees that are not considered small entities under the size standards in § 2.810 of Title 10 of the *Code of Federal Regulations*, "NRC size standards." Therefore, a significant number of the NRC's regulations do not affect small entities. However, there are a few rules that do have a significant impact on a substantial number of small entities. A complete list of those rulemakings that have an impact on small entities and their corresponding guidance documents is available on the agency's small entity compliance guide Web site at <http://www.nrc.gov/about-nrc/regulatory/rulemaking/flexibility-act/small-entities.html>.

Since our May 24, 2016, correspondence, only one new rule has been determined to have a significant impact on a substantial number of small entities. This final rule amended the licensing, inspection, and annual fees that the NRC charges to its applicants and licensees (June 24, 2016; 81 FR 41171). The final rule's small entity compliance guide is the last entry in the list on the agency's small entity compliance guide Web site.

In addition, one compliance guide posted on the agency's Web site has been superseded by a revision. The new version is NUREG-1556, Volume 1, Revision 2, "Consolidated Guidance about Materials Licenses: Program-Specific Guidance about Portable Gauge Licenses." This revision is posted on the agency's small entity compliance guide Web site.
