Regulatory Improvements for Power Reactors Transitioning to Decommissioning: Preliminary Draft Regulatory Analysis; Request for Comment; Parts 26, 50, 52, 73, and 140 of Title 10 of the Code of Federal Regulations (Regulation Identifier Number 3150-AJ59; NRC-2015-0070)

On May 9, 2017, the NRC published a document in the *Federal Register* ([82 FR 21481](#)) requesting comment on the preliminary draft regulatory analysis to support a rulemaking that would amend the NRC's regulations for the decommissioning of nuclear power reactors. The NRC's goals in amending the regulations would be to provide for an efficient decommissioning process; reduce the need for exemptions from existing regulations; address other decommissioning issues deemed relevant by the NRC; and support the principles of good regulation, including openness, clarity, and reliability. The NRC plans to hold a public meeting to discuss the draft regulatory basis that was previously published in the *Federal Register* on March 15, 2017 ([82 FR 13778](#)), and the preliminary draft regulatory analysis to facilitate the development of public comments on those documents. Comments are due by June 13, 2017.
