**Naturally-Occurring and Accelerator-Produced Radioactive Materials; Petition for Rulemaking (PRM); Extension of Comment Period; Part 30 of Title 10 of the Code of Federal Regulations (10 CFR) (PRM 30-66; NRC-2017-0159)**

On November 6, 2017, the NRC published an FRN in the *Federal Register* ([82 FR 51363](#)) extending the comment period for a PRM that was published on August 23, 2017 ([82 FR 39971](#)), by Matthew McKinley on behalf of the Organization of Agreement States. The comment period that was due to close on November 6, 2017, was extended for 30 calendar days to allow more time for members of the public to develop and submit their comments. Comments should be filed no later than December 6, 2017.

**Miscellaneous Corrections; Final Rule; 10 CFR Parts 2, 9, 40, 50, 61, 71, 73, and 110; (Regulatory Identifier Number (RIN) 3150-AK08; NRC-2017-0170)**

On November 15, 2017, the NRC published a final rule in the *Federal Register* ([82 FR 52823](#)) amending its regulations to make miscellaneous corrections. The amendments include correcting references, an address and a misspelling. The amendments will also make references to persons in one part of the NRC's regulations gender neutral. This document is necessary to inform the public of these non-substantive amendments to the NRC's regulations. This rule is effective December 15, 2017.

**Emergency Preparedness Requirements for Small Modular Reactors and Other New Technologies; Regulatory Basis; Availability; 10 CFR Parts 50 and 52 (RIN 3150-AJ68; NRC-2015-0225)**

On November 15, 2017, the NRC published an FRN in the *Federal Register* ([82 FR 52862](#)) making available a regulatory basis document in support of a rulemaking that would develop new emergency preparedness (EP) requirements for small modular reactors (SMRs) and other new technologies (ONTs), such as non-light-water reactors and medical isotope production facilities. The regulatory basis concludes that there is sufficient justification to proceed with rulemaking to develop a clear set of rules and guidance for EP for SMRs and ONTs. The regulatory basis also concludes that the principle of using a dose-at-distance and consequence-oriented approach to determine the appropriate size of an emergency planning zone can be applied to SMRs and ONTs. The NRC is not seeking public comment on this document. There will be an opportunity for formal public comment on the proposed rule when it is published in the *Federal Register*. The regulatory basis was available on November 15, 2017.

**Public Meeting to Discuss Crediting FLEX Strategies and Equipment in Regulatory Applications**

On November 15, 2017, the staff held a Category 2 public meeting with the Nuclear Energy Institute, the Electric Power Research Institute, and several utilities to discuss crediting of FLEX strategies and equipment [the diverse and flexible coping capability, or “FLEX,” builds on earlier safety steps by providing an effective and efficient way to make U.S. nuclear energy facilities even safer] in regulatory applications beyond their original intent to mitigate Beyond Design Basis External Events. During the meeting, industry representatives and staff presented progress made in this area and identified challenges (e.g., staff’s ability to access operational experience on FLEX equipment and alignment on how FLEX strategies can be incorporated into probabilistic risk assessment models) that could inhibit progress. At the conclusion, the staff proposed (and industry agreed) to reflect on the information discussed at the meeting and hold the next meeting to discuss high-level strategies to address anticipated challenges.

**Peach Bottom, Units 2 and 3 - Approval of Extended Power Uprate**

On November 15, 2017, the staff approved a 1.66% measurement uncertainty recapture (MUR) power uprate for Peach Bottom, Units 2 and 3. Stretch and extended power uprates were previously approved for Peach Bottom. As such, the MUR represents a power level equivalent to 122% of the original licensed thermal power level. The licensee plans to implement the MUR for both units within 90 days.
