## Elimination of Immediate Notification Requirements for Non-Emergency Events; Petition for Rulemaking (PRM); Notice of Docketing and Request for Comment; 10 CFR Part 50 (PRM-50-116; NRC-2018-0201

On November 20, 2018, the NRC published a notice of docketing in the *Federal Register* (83 FR 58509) for a PRM submitted by Bill Pitesa, of the Nuclear Energy Institute, dated August 2, 2018, requesting that the NRC amend its regulations regarding the immediate notification requirements for operating nuclear power reactors. The petition was docketed by the NRC on September 4, 2018, and has been assigned Docket No. PRM-50-116. The NRC is examining the issues raised in PRM-50-116 to determine whether they should be considered in rulemaking. Comments are requested by February 4, 2019.

#### <u>Miscellaneous Corrections; Final Rule; 10 CFR Parts 26, 30, 40, 50, 70, 73, and 110</u> (RIN 3150-AK15; NRC-2018-0200

On November 20, 2018, the NRC published a final rule in the *Federal Register* (83 FR 58463) amending its regulations to make miscellaneous administrative updates and corrections. The amendments include removing obsolete language and correcting references, an appendix, operating hours, a telephone number, an inconsistency in a definition, and an office title. This document is necessary to inform the public of these non-substantive amendments to the NRC's regulations. This final rule is effective December 20, 2018.

### Miscellaneous Corrections – Organizational Changes; Final Rule; Parts 37, 40, 70, 71, 72, 73, 76, and 95 of Title 10 of the *Code of Federal Regulations* (10 CFR)(Regulatory Identifier Number (RIN) 3150-AK13; NRC-2018-0086

On November 21, 2018, the NRC published a final rule in the *Federal Register* (83 FR 58721) amending its regulations to make miscellaneous administrative updates and corrections. The amendments include removing an office from a list of office recipients, removing an office reference, correcting an office designation and a phone number, removing and correcting division titles, and removing a followup reporting instruction. This document is necessary to inform the public of these non-substantive amendments to the NRC's regulations. This final rule is effective December 21, 2018.
