On behalf of the Commission, I am providing the April 2019 monthly status of the U.S. Nuclear Regulatory Commission (NRC) activities and use of unobligated carryover funds appropriated from the Nuclear Waste Fund. The enclosure provides the Nuclear Waste Fund expenditures in April 2019 to address the remand by the U.S. Court of Appeals for the District of Columbia Circuit in the case *In re Aiken County* regarding the licensing process for the U.S. Department of Energy's Yucca Mountain license application.
