P R O C E E D I N G S

CHAIRMAN SVINICKI: Well good morning everyone. It's wonderful to see everyone's eyes smiling, or as they call it "smizing," it's nice to see everyone smiling over their masks today. We're going to begin our meeting on the agency's response to COVID in a moment. Before that the Commission has two affirmation items so we will go into a brief affirmation session right now. Madam Secretary, I understand we have two items for affirmation. Would you please lead us through?

ANNETTE VIETTI-COOK: Yes. The first item is on SECY-20-0011, El Paso Electric Company (Palo Verde Nuclear Generating Station). The Commission is being asked to act on a Memorandum and Order responding to Public Citizen's petition for leave to intervene and request for hearing in the license transfer proceeding concerning an application filed by El Paso Electric Company on behalf of itself and IIF US Holding 2 LP. The application seeks NRC approval of an indirect transfer of El Paso Electric Company's non-operating interest in the renewed facility operating licenses for Palo Verde Nuclear Generating Station Units 1, 2, and 3 and the associated general license for the independent spent fuel storage installation to IIF US Holding 2 LP.

The Commission has voted to approve a Memorandum and Order denying the request for hearing and petition to intervene and terminating the proceeding.

Would the Commissioners in the room please affirm your votes?

ANNETTE VIETTI-COOK: The second item is on 20-0043, Direct Final Rule: Reactor Vessel Material Surveillance Program. The Commission is being asked to act on a direct final rule and companion proposed rule that amends Appendix H, "Reactor Vessel Material Surveillance Program Requirements," to Part 50 of Title 10 of the *Code of Federal Regulations*, "Domestic Licensing of Production and Utilization Facilities." Specifically, the direct final rule makes optional the testing of specimens that do not provide meaningful information to assess the integrity of the reactor vessel; extends the timeframe for licensees to submit the summary technical report of each capsule withdrawal and the test results from 1 year to 18 months; and clarifies the requirements for the design of surveillance programs and the capsule withdrawal schedules for reactor vessels purchased after 1982. The Commission has voted to approve the publication and implementation of this direct final rule and the companion proposed rule subject to the changes noted in the in attachments. Additionally, the Commission has certified that this rule will not have a significant impact on a substantial number of small entities.
