SUBJECT: NEW HAMPSHIRE FINAL REVISIONS TO RATS ID 2022-2 and 2023-1

Dear Augustinus Ong:

We have reviewed the final revisions to the New Hampshire He-P 4030 and He-P 4035, received by our office on December 29, 2023. These regulations were reviewed by comparison to the equivalent U.S., Nuclear Regulatory Commission (NRC) rules and Regulation Amendment Tracking System Identification Numbers (RATS ID) 2022-2 and 2023-1 and as identified in the enclosed State Regulation Status (SRS) Data Sheet. We discussed our review of the regulations with you on January 23, 2024.

As a result of our review, we have no comments. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that the regulations, as adopted, meet the compatibility and health and safety categories established in the Office of Nuclear Material Safety and Safeguards (NMSS) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."

The SRS Data Sheet summarizes our knowledge of the status of other New Hampshire regulations, as indicated. Please let us know if you note any inaccuracies or have any comments on the information contained in the SRS Data Sheet.
